HUMAN POPULATION COMPETITION

A Study of the Pursuit of Power Through Numbers

by Jack Parsons

The author's previous works include two widely read and admired books, *Population Versus Liberty* (1971, UK/1973, US) and *Population Fallacies* (1977, UK). The former has come to be accepted by a number of experts in the field as the standard work on population control vis-à-vis personal freedom. In this new work he argues that although there exists some sound literature on the fear of population decline, the wider topic of an overtly confrontational kind of population competition, often centered on competitive breeding, is almost universally avoided. The analytical frame in which this study is set is that there is an already serious but rapidly growing compound problem of population/poverty/development/pollution and conservation involving a low quality of life for many hundreds of millions, and that anything tending to worsen the situation, such as increases in the already explosive human population growth rate, is seriously dysfunctional. Includes tables, figures, photographs, and very full indexes.
