Should We Fear?

Up to the darkest hours in recent German history, Jews had permeated many of the leading professions, dentists 30 per cent; lawyers 40 to 45 per cent; physicians 50 per cent; those connected with schools and hospitals up to 80 per cent. And this, although the Jewish population was only one per cent of the total. Jews occupied important key positions in the government and moulded public opinion through their control of press, movie and radio. Ultimately, Hitler broke the stranglehold of this octopus, and this led to the present developments in Germany. Parallel movements took place in other European countries.

Is there any lesson for us in all these events? Have we anything to fear from too many Jews in our Government? Can any influence upon our public opinion be traced to Jews? Are they likely to get control in any of our leading professions? What is their percentage in them, and what in comparison to our total population?

There are good Jews and bad Jews. I can and do distinguish between them. As long as they mind their own business and do not interfere with that of other people, I have no objection to them. But, I seriously object to their interference with our public affairs, with the policies of the government or our attitude to other nations.-W. C. R., Detroit, Mich.

THE measures recently enacted or proposed in Italy with regard to the Jews came as a surprise to most foreigners and to many Italians as well, since members of that race had never been discriminated against in that country.

However, the new policy was the outcome of long reflection, and many phases are to be considered if an understanding of the problem is to be arrived at.

During the last eighteen or twenty years there has been an influx of Jews from Russia, Poland, Hungary, Roumania and more recently from Germany and Austria, estimated at 200,000 to 250,000. This created a serious economic problem, especially in certain professions and trades.

It was this economic situation which led to the recent measures whereby foreign Jews who entered and settled in Italy since 1919 are to leave the country within a few months.

Many other causes must also be considered in this Italian-Jewish question.

The opposition of the Communistic Jewish element to the Fascist government; the discovery that many Jewish financiers and speculators were engaged in illicit operations in Italian currency and securities; the fact that many branches of intellectual life were presided over largely by Jews; disagreement with the Fascist government with regard to the Palestine question; opposition to the government's policy with regard to racial discriminations in Ethiopia, where several measures of a racial character were enacted to prevent the evils of miscegenation-all these had a direct and important bearing upon the Fascist government's attitude towards the Jews, especially since many of them were foreign Jews.

Italy's Jewish policy, however, is of a mild nature compared with that of other countries. Anti-Semitism has never flourished in Italy, and the measures adopted or in course of adoption aim at two objects: To rid the country of the large numbers of foreign Jews and, in reference to the Italian Jews, the objective is to eliminate the effects of the presence of an alien element in the body politic. No discrimination is likely to be adopted regarding the activities of the Italian Jews which are not detrimental to public policy or in connection with individuals who have proven themselves to be genuinely assimilated and who deserve to be regarded as patriotic Italians.
