Anti-Semitism in Industry

THE communistic Daily Worker in its Sunday edition (July 21) inferentially tells a story of the rise of anti-Semitism in America.

While we do not agree with the entire content of the article from the *Daily Worker*, we reprint it to show the trend of thought upon which some Jews have launched.

Here it is:

"A blood-dipped Swastika may as well float openly over a great portion of American industry as far as the job chances of Jewish-American workers are concerned.

"Repugnant as it is to all notions of democracy and freedom, the foul and frightful Nazi principle of 'down with the Jews' is still the policy of numberless huge American firms and corporations, many of them now engaged on the defense program which has as its aim the destruction of Hitlerism.

"It is not a paradox, it is the logic of reaction that the Jewish people who, as a people, have the greatest reasons for detesting Hitler and all his works and would be an enormous asset to American industry and production — and whose unflinching loyalty and devotion to the principles of American democracy are unquestioned — are deliberately barred from taking their rightful place in the defense program.

"Many of these same corporations which are so vigilant against the Jews are strangely lax in the detection of fifth columnists and in more than one firm engaged in defense production there have recently been discovered Nazi spies and saboteurs.

"Last week in the spacious chambers of a sub-committee of the House Judiciary Committee in Washington a mild-mannered and soft-spoken Rabbi presented factual evidence of widespread and growing anti-Semitism in this country which is, in effect, nothing more than a monstrous economic pogrom.

"The Rabbi was Moses Miller, president of the Jewish People's Committee, and he spoke in behalf of 30.000 members. His testimony was offered in support of the Marcantonio anti-discrimination bill which would 'prohibit discrimination against persons employed or seeking employment on government contracts because of race, color or creed' under penalty of fines ranging up to \$50,000.

"Rabbi Miller told the Congressmen that 'economic discrimination against the Jewish people, as well as other minority groups, runs like a dark thread through the fabric of American life' and he warned them that the entire defense effort against Hitlerism is being nullified by tolerance of Hitler-like measures at home.

"'Employment agencies,' he said, 'in every part of the country continue to advertise for "Christians only."'

"He even quoted Government agencies which themselves had noted the alarming rise and increase in discrimination against Jews.

"He listed for the Congressmen some of the leading firms guilty of discrimination, among them being the Carl Norden Co., New York City; Western Electric; Federal Shipyards and Drydocks, Kearney, N. J.; American Telephone and Telegraph; General Electric; Aluminum Co. of America; Diehl Machine Co.; duPont; Boeing Aircraft; Colt Patent Firearms Manufacturing Co.; Niagara Hudson Power Co.; and Eastman Kodak.

"Some of these firms, Rabbi Miller said, sought to deny discriminatory policies but refused to make public the number or proportion of Jewish workers on their payrolls.

Others he cited as having strong Nazi tie-ups, one of these being the Diehl Machine Co., large portions of whose stock are in the hands of a nephew of Hjalmar Schacht, and another being the Aluminum Co., now under Federal anti-trust indictment for its agreement with the German I. G. Farben-Industrie.

"The Norden Co., makers of bombsights, employs Nazi sympathizers, and only recently one of its employes was arrested as a Nazi spy. The company completely bars Jews from employment.

"Other companies listed by Rabbi Miller which make a practice of specifying 'Christians' in their requests to the New York Employment Service for workers are:

"Brewster Aircraft; Bethlehem Steel; Packard Motor Co.; Ford Instrument Co.; Sperry Gyroscope; Mack Trucking International; and the Cutler-Hammer Co.

"Also cited were long lists of firms which bar Jews in a subtle or concealed manner, but no less effectively.

"Rabbi Miller presented for the consideration of the Congressmen the results of interviews with directors of technical defense training schools, one of whom was quoted:

"'Jewish engineers don't stand a chance at the Western Electric Co. in Kearney, N. J. We have difficulty in placing Jewish professional men in a number of fields. For example, in naval architecture it is almost hopeless for a Jew to find employment. Similarly it is difficult for Jewish engineers to find employment in such firms as duPont and the Aluminum Co. of America.'

"Others were quoted similarly.

"In defense training classes sponsored by the Government, Rabbi Miller charged, discrimination is also rife, despite a specific Congressional prohibition of it accompanying an appropriation of \$5,500,000 to establish such classes.

"'Jews and Negroes,' Rabbi Miller said, 'find it difficult to get training because the school boards declare that they consider it wasteful to train men who are not likely to get jobs. They use as the basis of their action the order in the service Bulletin on Defense Training issued by the United States Office of Education on December 13, 1940, which says: "The final test of a selection program is employment of the trainees on a job."

"The full testimony of Rabbi Miller before the sub-committee will be issued this week as a pamphlet by the Jewish People's Committee, which is pressing its drive in behalf of the Marcantonio Bill with appeals for all interested persons to write to their Congressmen; for organizations to send delegations to visit their Congressmen; and for all organizations to adopt resolutions to be sent to their Congressmen.

"'The Marcantonio Bill,' said Rabbi Miller in concluding his testimony, 'is the pre-requisite to any sincere effort on the part of government to abolish discrimination in defense industry. Passage of the Marcantonio Bill will give sincerity to the contention that we are fighting to destroy abroad what we cannot and will not tolerate at home."

Meanwhile, America is waiting for responsible Jewish organizations to petition Mr. Roosevelt to live up to his pre-election pledges of keeping America out of war and keeping American sons from fighting on foreign soil.

Shall Russians Pray to God—or Stalin?

"Russian Orthodox Church Prays for Red Russia!"

Thus boast the new Soviet Russian apologists in selling a "moral responsibility" bill of goods to the American public for all-out aid to godless Communism.

But a group of loyal American citizens of Russian descent, headed by Archbishop Vitaly of the Russian Orthodox Church, thinks otherwise.

Here is part of a protest letter they sent President Roosevelt a few weeks ago, which only a few papers in America dared print:

"We feel that the center of gravity of the situation rests not so much in military operations, though these are developing on a gigantic scale, as in the cataclysmic conflict of two fundamental principles — the Christian principles of spiritual tolerance and social and political liberty on the one hand, and the anti-Christian principles of narrow intolerance and political oppression on the other.

"In this historical conflict, the Russian people stand before a tragic dilemma. Either to take advantage of the German attack against Stalin for their liberation from the Soviet yoke, or by bowing to Stalin, to give up forever the hope of shaking off the shackles of Communist slavery.

"It is with grave concern and profound regret that this committee, representing loyal Americans of Russian descent, is viewing a well-marked tendency on the part of certain officials of the Administration to extend America's material assistance, not to Russia, not to the Russian people, but to the Red dictatorship personified by Stalin."

The committee also points out that Russia today is "dominated by a vicious clique of international plotters" with world revolution its objective.

Working in direct co-operation with the "international plotters" of Moscow are the financial and Communist "international plotters" in the United States.

At a Madison Square Garden meeting, sponsored by the American Council on Soviet Relations, these unholy internationalists joined hands two weeks ago to applaud the great Democrat Stalin.

Corliss Lamont, capitalist turncoat to Communism and vice-chairman of the Council on Soviet Relations, presided.

In the audience, for the first time since his son espoused Communism, sat Thomas A. Lamont, international banker and a Morgan partner.

At the end of young Lamont's speech in which he declared that the fall of Russia would be "the evilest day that ever fell upon mankind," father Lamont timidly unfolded his hands and clapped.

Mark Twain Up-to-Date

IN HIS BOOK, "The Mysterious Stranger," Mark Twain said of war:

"There has never been a just one, never an honorable one — on the part of the instigator of war. I can see a million years ahead, and this rule will never change in so many as half a dozen instances. The loud little handful, as usual, will shout for the war. The pulpit will, warily and cautiously, object at first, the great big bulk of the nation will rub its sleepy eyes and try to make out why there should be a war and will say earnestly and indignantly, 'It is unjust and dishonorable, and there is no necessity for it.'

"Then the handful will shout louder. A few fair men on the other side will argue and reason against the war with speech and pen, and at first will have a hearing and be applauded; but it will not last long; those others will outshout them, and presently the anti-war audiences will thin out and lose popularity. Before long you will see this curious thing: the speakers stoned from the platform and free speech strangled by hordes of furious men who in their secret hearts are still at one with those stoned speakers, as earlier, but do not dare to say so.

"And now the whole nation, pulpit and all, will take up the war cry, and shout itself hoarse and mob any honest man who ventures to open his mouth; and presently such mouths will cease to open. Next the statesmen will invent cheap lies putting the blame upon the nation that is attacked, and every man will be glad of those conscience-soothing falsities, and will diligently study them, and refuse to examine any refutations of them; and thus he will by and by convince himself that the war is just and will thank God

for the better sleep he enjoys after this process of grotesque self-deceptions."

Self-deceptions are the order of the day. Getting into war is like getting into sin. It is thrilling. It is romantic. It is passionate. It is all-devouring.

Then comes the sin. When the lamp of passion is burnt out, then come reaction and remorse.

The trouble in the past is that the poor people have forgiven and forgotten those who brought about the world's wars.

They were so interested in finding a job, or a crust of bread, they forgot to discover the identity of those who made jobs scarce as well as bread.

Meanwhile, we are deceived, temporarily, with high wages for the working people.

We are deceived, temporarily, with high lies and low speeches pronounced by slimy-tongued politicians.

Meanwhile, the Father Coughlins, the Burton Wheelers and Charles Lindberghs are figuratively stoned from platforms, while free speech is strangled in pulpit and on rostrum.

Meanwhile, Germany oppresses a Niemoeller and militates against Catholicism and Protestantism.

Meanwhile, Red Russia is sanctified as she enters the holy circles of the Allies, the democracies, who fight against the aggressors, including Finland.
